## SCOPE AND OBJECTIVES OF THE AWARD SCHEME

National Safety Council - Tamil Nadu Chapter Proposed to recognize and reward the organizations for the exemplary Occupational Safety & Health (OSH) performance and commitment to reduce work place injuries, implementations of the best OSH practices and encourage continual improvements.

National Safety Council institutionalized two distinct awards schemes for the **Manufacturing Sector and Construction Sector (Introduced from this year)**.

### AWARD CATEGORY - MANUFACTURING SECTOR

#### Eligibility

All Industries registered with Government of Tamil Nadu under the Factories Act 1948, are eligible to participate in the Award Scheme.

#### ASSESSMENT PERIOD - MANUFACTURING SECTOR

- 2021 January to December
- 2022 January to December

### AWARD CATEGORY - CONSTRUCTION SECTOR

#### Eligibility

Any Establishment registered under the building and construction workers (Regulation of Employment and conditions of Service) Act, 1996 (BOCW (RECS) Act 1996) with Government of Tamil Nadu for Executing "Building and other Construction Work" as defined under this Act and Employed 100 or More Building workers in the Project for at least 180 days during the assessment period.

(OR)

Any Contractor licensed / Any Establishment registered under the Contract Labour (Regulation and Abolition) Act 1970, with Government of Tamil Nadu for executing "Building and other Construction work" as defined under the BOCW (RECS) Act, 1996 and employed 100 or more building workers in the project for at least 180 days during assessment period.

#### ASSESSMENT PERIOD - CONSTRUCTION SECTOR

- 2022 January to December

### ABOUT THE AWARD

The awards are presented to those organization who performed the best among the participating organizations by the award committee.

#### Categories of Awards are

 **Champion Award**

 **Award of Honour**

 **Star Award**

 **Appreciation Award**

 **Participation Award**

The Awards committee will decide upon the number of Awards in each Category of Awards based on the eligibility criteria.

At the discretion of the Awards Committee, participation award may also be issued to those Industries deserved to be recognized for their Occupational Health, Safety & Environment (OHSE) performance who are not selected for other Award.

## **METHODOLOGY**

A questionnaire will be sent to all Participants on receipt of the application form. All applicants shall fill the questionnaire with all necessary details and forward to National Safety Council – Tamil Nadu Chapter. The Evaluation will be based on the weightage given to Individual OHSE elements of the questionnaire. The Awards Committee will decide to Visit the industries as applicable.

**Please note that industries reported “Fatal Accident” during the above mentioned period shall not be eligible to participate for this award.**
