

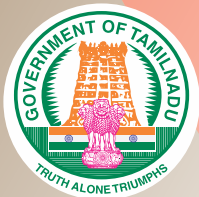

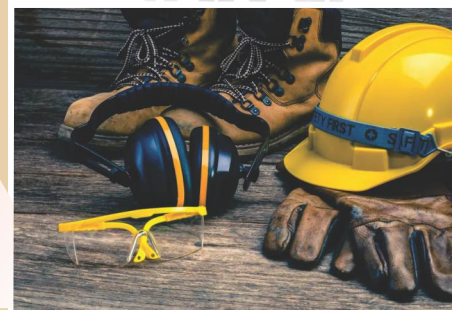
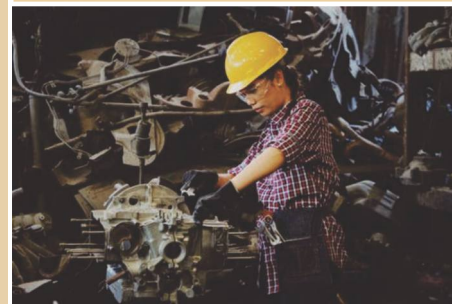

Programme Perspective:

Occupational Health, Safety and HR are cross-functional areas concerned with protecting the Safety and Health of people engaged in work or employment. The goal of all occupational health and safety and HR programs is to foster a safe work environment. As a secondary effect, it may also protect co-workers, family members, employers, customers, suppliers & stake holders, and other members of the public who are impacted by the workplace environment. It may involve interactions among many subject areas, including Accident Case Studies and Legal Requirements, Health, Safety and Welfare Professionals – The Relationship, Employee Engagement in Health & Safety Movement – HR perspective, Safety Differently Innovative and Critical Safety Thinking & ISO 45001: 2018 – An Overview, etc.

Unlike other functions of management, Safety and Occupational Health activities encompasses all other functions as it involves the life of individuals and property of the organization as it has no boundaries and barriers to work with. Safe working environment and health of the employees are key parameters for measuring the success of an organization. The Safety and health policies are increasingly designed to give emphasis to create necessary awareness, employee involvement and commitment in prevention of accidents and promote the culture of safety and health in an organization.

As people practitioners, HR has the unenviable task of balancing the best interests of employees and their organizations. In this process, HR professionals play an important role in ensuring health and safety, as they know workplace, employees and their jobs demands. Considering the increasing realization on the serious impact on the working of an organization due to accidents, be it minor or major, ill health of employees, organizations are giving thrust in educating the employees on safe working, use of personal protective equipment's, early detection of symptoms of occupational diseases for the betterment of employees well-being.

In this direction, any initiative taken to promote safety is incomplete without the involvement of all categories of employees working in the work place.

Overlapping Responsibilities

- Fostering a Work place safety culture in which employees and their supervisors or middle management work together to ensure workplace safe.
- Encouraging active participation of employees' leaders/members in EHS Programs etc. to prevent work related injuries and illness with the view to nil man days lost on account of accidents.
- Establishing administrative procedures that encourage employees to report unsafe work conditions and unsafe practices to their supervisors without fear of being disciplined.
- Ensuring that health and safety policies and procedures conform to the applicable occupational health and safety regulations/provisions and bring best practices prevailing in the industries.
- Maintaining records of injuries, illness, disabilities, employee compensation and health care.

- Helping reduce costs associated with losses due to absenteeism, injuries, Employees compensation disability and health care.
- HR, Medical Officers & Safety Professional need to work hand in hand to make Value added training programs on safety and health to up-date and up-grade the knowledge and best safety practices constantly for the active involvement and participation of employees.

Considering the importance of role to be played by Safety professionals, HR and this program has been designed to focus specific areas such as compliance with various provisions, jointly coordinating health, HR and safety activities, Risk prevention exercises, accident analysis for prevention etc. to upgrade the knowledge and practices for bringing safe working culture in the organization.
